4a (Code:) (Expenses \$ 144,607. including grants of \$) (Revenue \$) Pro Bono Partnership of Atlanta (PBPA) provides free legal assistance to community-based nonprofit organizations that serve poor or disadvantaged individuals in or around Metropolitan Atlanta. PBPA matches eligible organizations with volunteer attorneys from corporations and law firms who can assist PBPA's nonprofit clients with their business law matters.

In 2011, PBPA provided free legal assistance to 174 nonprofit organizations. Over 430 volunteer attorneys were matched with 530 different legal matters for nonprofits. Volunteer attorneys provided free legal assistance to PBPA clients valued at approximately \$2.3 million.

4b (Code:) (Expenses \$ 72,303. including grants of \$) (Revenue \$) PBPA also hosts a quarterly Nonprofit Legal Check-Up program. The Nonprofit Legal-Check Up is a half-day program that trains attorneys and then pairs them with a nonprofit organization to identify the issues that may affect the legal health of the organization. Forty nonprofit organizations and over 100 attorneys and paralegals participated in the Nonprofit Legal Checkup in 2011.
